

NOTICE OF PROPOSAL
CHESHIRE EAST BOROUGH COUNCIL (OFF-STREET PARKING PLACES) (CONSOLIDATED) ORDER 2015 (VARIATION NO. 12)

Notice is hereby given that Cheshire East Borough Council propose to make an Order in exercise of its powers under Sections 32, 35, 35C and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, ("the 1984 Act") and all other enabling powers and in accordance with its duty under Section 122 of the 1984 Act.

The effect of the Order will be to vary the Cheshire East Borough Council (Off-Street Parking Places) (Consolidated) Order 2015 (as amended) as follows:

1. To amend the Charging Days and Hours in the Schedule to the Order as follows:
 - (i) Amend from "Monday to Saturday" to "Monday to Sunday"
 - (ii) Amend from "8am to 6pm" to "8am to 10pm"
